Elder Mediation: Essential Knowledge, Values and Skills 30 hours of Online Training

- ➤ This professional development program is designed to enhance your present knowledge and skills in this fast-emerging field. A central theme is to sensitise participants to the needs, experiences and challenges facing older people, their families and communities and the implications for mediation.
- ➤ Elder Mediation is a voluntary, person-centred, preventative, respectful process usually multi-party, multi-issue and intergenerational. The mediator facilitates discussions focusing on present strengths and assists participants in addressing their stated wishes or concerns. Elder Mediation normally involves a large and more varied number of participants.
- ➤ Face-to-face programs have been successfully delivered by the presenter in most Australian States and New Zealand for Relationships Australia, the Resolution Institute and other groups of experienced mediators and an enhanced, popular online 30-hour program was provided annually from 2022 2025.
- ➤ To assist mediators to complete the 30-hour elder mediation training, the course is being divided into two sections the first section of 20 hours of knowledge-building can be completed online in the participant's own time, and the second section of 10 hours will involve online supervised roleplays with a highly experienced trainer. The 10-hour skills training will be available to people who have previously completed 20 hours of elder mediation training.

Your Elder Mediation Certification or CPD Hours

This course, in total, provides thirty (30) hours towards the Elder Mediation International Network's (EMIN) Elder Mediator Certification, which is now required by the Australian Mediation and Dispute Resolution Standards (AMDRAS) Board for AMDRAS accreditation as a specialist elder mediator.
